



Meevo®2 Connector for Workforce Now Powered by ADP®

Frequently Asked Questions

What does the Meevo 2 Connector do?

The Meevo 2 Connector allows you to seamlessly and securely upload payroll data from Meevo 2 into Workforce Now Powered by ADP. Note that this integration cannot be purchased until your business has completed at least one full payroll period with ADP®.

Who should use Meevo 2 Connector?

The Meevo 2 Connector is intended for those within your business who manage your employee payrolls.

What are the benefits of using Meevo 2 Connector?

Meevo 2 Connector can save you time by helping you eliminate the need for extra spreadsheets, lower operational expenses, and improve efficiency. You can also help mitigate compliance-related issues, as errors from manual entries are significantly reduced. Payroll is transferred quickly and securely using the latest security standards.

How do I configure the Meevo 2 Connector?

As part of the setup, employee and earning code data are pulled from Workforce Now into Meevo 2. In Meevo 2, you'll map your Meevo 2 employees to your Workforce Now employees, as well as your Meevo 2 wages and commission to Workforce Now earning codes.

Is payroll submission scheduled or real-time?

Submitting a payroll is always a manual action that is performed by selecting **Submit to ADP** via the Meevo 2 payroll screen.

When should I submit payroll to Workforce Now?

Submit your payroll to ADP at the end of your payroll period, after you've verified that the payroll data provided by Meevo 2 is accurate.

How is payroll submitted to Workforce Now?

Payroll is still processed in Meevo 2. Within the Meevo 2 payroll screen is a **Submit to ADP** button, which sends that payroll data to Workforce Now.

How much does the Meevo 2 Connector cost?

The Meevo 2 Connector has a recurring monthly fee of \$50, with payment being submitted to ADP, not Millennium Systems International.

Is it possible to submit the same payroll twice?

There is no limit to how many times you can submit a payroll period; each submission will simply overwrite the last. The Meevo 2 Payroll screen offers several ways to verify whether a period has already been sent, and extensive ADP logs are available for review on this screen as well.
