## INFRASTRUCTURE

- Ceiling heights (slab to slab): 11' 6" -14"
- Column spacing 15' - 21'
- Floor loading: 200-300 lbs/sf
- Secure loading area

- Fire suppression: pre-action, dry pipe
- Cable management: overhead ladder rack
- Outside the 500-year floodplain
- 24/7 network operations center (NOC)

- Pre-built innerduct system from POEs to MMR

- Backup generator power: 5,000 kW (N+1)
- DC power distribution available
