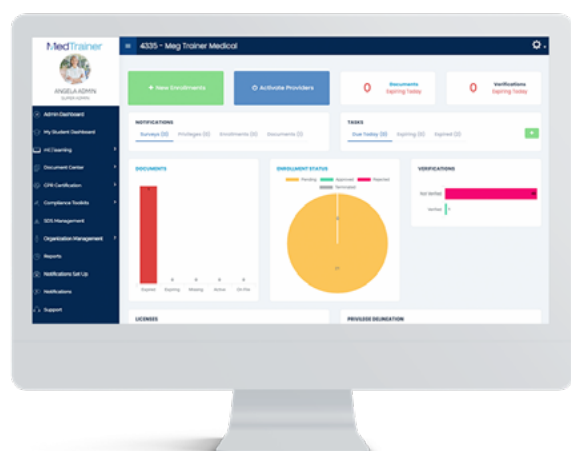

The **admin dashboard** provides an at-a-glance view of your organization's credentialing, including tasks, notifications, and progress.

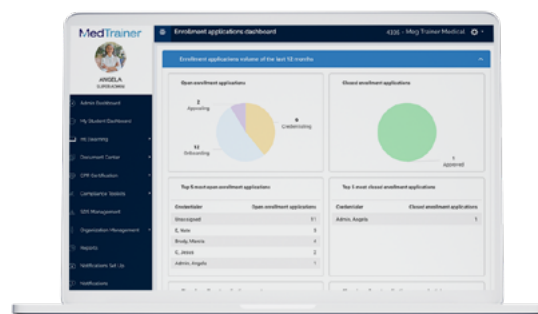


- Save time with the ability to quickly activate multiple enrollments

Executive-Level View of Enrollments

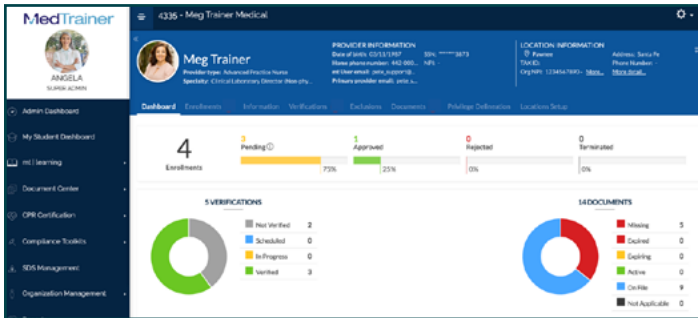
The **enrollment applications dashboard** provides a comprehensive overview of the enrollment process, including performance, highlights, and possible risks so you can make informed decisions.

Enrollments

Information

Verifications

- Always know a provider's status with verification details at a glance

- Verify provider taxonomy and other data points with NPPES integration

Exclusions

- Quickly identify excluded individuals and mitigate federal reimbursement ineligibility risks
- Schedule exclusions to run monthly for OIG/SAM and state exclusion lists

Documents

- Customize the list of required documents for each location so every affiliated provider uses the same preset document list
- Electronically request documents from a provider and share a secure link for upload
- Automatic notifications for all expiring items starting at 90 days from expiration

Credentialing Reports

- Customize reports with the data you need such as clinical privileges, verifications, exclusions, and documents
- Regularly review all your providers' payer enrollments to ensure your claims are legitimate and valid
- Schedule reports, such as exclusions and licenses, to run on a set cadence (daily, weekly, monthly)
